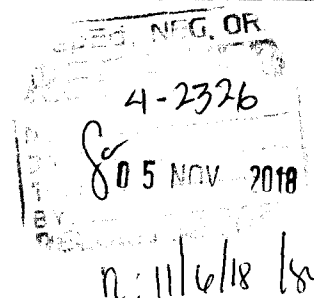

Greetings!

The Rotary Club of Dumaguete North (RCDN) is organizing an Inter-High School "Battle of the Bands-for a Cause". This activity will be held on February 8, 2019 from 6:00 PM to 9:00 PM at the Lamberto Macias Sports Complex in Dumaguete City.

In view hereof, we are respectfully writing you for the purpose of seeking the approval of your esteemed office so that our club can invite the Negros Oriental High School and other High Schools (Junior and Senior) in the neighboring towns of Bacong, Valencia and Sibulan to send one (1) participating band each High School composed of at least one (1) Vocalist, Drummer, Guitarist, Bassist, Keyboardist and other instrumentalists provided that the band members will not exceed eight in number.

This activity will showcase our youth's musical talent and encourages others who have passion for music to get involved with it. Members of the School Faculty and/or Staff, but not to exceed two (2), can join the band if there is lack of musician/s to complete the group.

We likewise seek your permission that we be allowed to sell tickets to public and private schools situated in the above municipalities, through the respective PTA's in the participating school. Fifteen percent (15) percent of the ticket sales will go to the respective PTA's of the participating school which they can utilize to fund their projects.

Ticket prices will range from P100 to P150, depending on the viewer's seat accommodation. The prize for the Champion band will be P20,000; 1st Runner Up P15,000 and for the Second Runner up is P10,000.

Each band is required, *inter alia*, to render one (1) Original Pinoy Music (OPM) and one (1) Original Composition with lyrics encouraging the youth to promote, protect and preserve Mother Earth.

The net proceeds of the ticket sales will be used to fund various RCDN charitable/generous activities, such as, but not limited to, free medical, dental, animal vaccination/treatment and legal missions, giving of school supplies to destitute public school pupils, feeding programs.

Rest assured, our club will coordinate with PNP Dumaguete for the maintenance of peace and order during the above-named occasion.

We also humbly request your office to issue memoranda/notices to different Junior/High Schools in Bacong and Valencia and to Negros Oriental High School inviting them to send a band to compete in the above "Battle of the Bands-for a Cause".

We hope for positive and quick response from your office to this letter in the earliest possible opportunity. Kindly inform us forthwith once our request for approval to this undertaking shall have been granted already. We can be reached at these cell phone nos. 09263847958.
