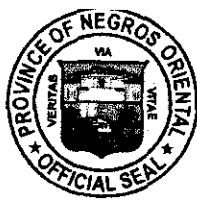

#### QUALIFICATIONS:

#### CREW MEMBERSHIP

- This Competition is open to all High Schools in Negros Oriental.
- Each member/ participant must be a bonafide Junior and Senior High student from their respective Schools.
- Each high school in Negros Oriental is encouraged to submit one (1) group as official entry. The endorsement letter from their respective school heads or duly authorized representative must be attached during the registration.
- Each crew may have a minimum of 10 and a maximum of 15 members.

#### LENGTH OF MUSIC

- The length of the music to use should NOT exceed 4 minutes and NOT go below 3 minutes.
- The final music should be submitted to the organizer at least a the day before the competition.

#### DANCE ROUTINE

- Visible inclusion of at least 4 of the following styles into the routine:  
Hip hop | Krump | Dance Hall | Urban Choreography | House  
Lock | Vouge | Waack | B boying | Popping | Strutting
- Furthermore, lewd and obscene actions are totally NOT allowed to be included in the routine, this includes, but not limited to showing of the Dirty Fingers.

#### COSTUMES AND PROPS

- All costumes must be worn appropriately. Lewd costumes that show too much flesh are strictly not allowed.
- Use of firecrackers, any form of liquids or liquor and alcohol, fire, confetti, powder, dangerous weapons, pointed items as props are strictly prohibited.

#### CRITERIA FOR JUDGING

- **PERFORMANCE**
  - Creativity 20%
  - Stage Presence 10%
  - Synchronization 10%
  - Audience Impact 10%
- **SKILLS**
  - Artistry and Ability 20%
  - Difficulty of Style 20%
  - Timing Ability 10%
