





This pertains to the grant of Special Hardship Allowance (SHA) and Cash Allowance to Teachers, pursuant to Special Provisions 10 and 11¹ of the General Appropriations Act for FY 2021 (GAA FY 2021); and the grant of Transportation Allowance and Teaching Aid for Alternative Learning System (ALS) Teachers and community ALS Implementers, pursuant to Special Provision 21² of GAA FY 2021.

The grant of Transportation Allowance and Teaching Aid for ALS Teachers (Mobile Teachers and District ALS Coordinators) and Community ALS Implementers is also stipulated in Section 22 of the ALS Act (Republic Act 11510), enacted on December 23, 2020:

“Notwithstanding the receipt of special hardship and cash allowances, ALS Teachers and Community ALS Implementers shall be entitled to their corresponding transportation and teaching aid allowances subject to guidelines that may be issued by the DepEd.”

However, President Rodrigo Roa Duterte’s Veto Message³ on Special Provision 21 of GAA FY 2021, dated December 28, 2020, imposed a conditional implementation on the grant of transportation allowance and teaching aid which shall be subject to the

guidelines issued by the Department of Education (DepEd) in coordination with the Department of Budget and Management (DBM), in conformity with existing laws, rules and regulations.

Upon consultation with the DBM, in compliance to President's Veto Message in 2021 GAA, the grant of Transportation Allowance and Teaching Aid to ALS teachers shall be allowed as long as the DepEd can guarantee that there shall be no double compensation. It was recommended that ALS Teachers shall either choose to receive SHA and CA or Transportation Allowance and Teaching Aid.

In relation to this, this Office and the ALS Task Force (ALS TF) is drafting a policy on the grant of Transportation Allowance and Teaching Aid to ALS Teachers and Community ALS Implementers to ensure that there shall be no double compensation. To aid the drafting of said policy, we need to determine who among our ALS Teachers nationwide will choose to receive the Transportation Allowance and Teaching Aid only or SHA and CA only.

All Division ALS Focal Persons are directed to submit to the Regional ALS Focal Persons the list (see Attachment 1) of all ALS Teachers in their respective division signifying which allowance shall be accorded them. The list must be duly signed by the Schools Division Superintendent.

The Regional ALS Focal Persons shall then collate the list submitted by the Division ALS Focal Persons (see Attachment II). The final list per Regional Office must be duly signed by the Regional Director.

All Regional ALS Focal Persons must submit the final list to the Office of the Assistant Secretary for ALS through email at asec.als@deped.gov.ph on or before April 30, 2021.

Note:

- The list submitted to the Office of the Assistant Secretary for ALS shall be valid for one (1) year and shall be the basis of ALS TF in computing for the Transportation Allowance and Teaching Aid for FY 2021.
- The list shall be submitted by the ALS TF to the BHROD-School Effectiveness Division as basis for granting SHA.

To help in the decision-making of our ALS Teachers, here is the comparison of SHA and CA vis-à-vis Transportation Allowance and Teaching Aid.
