1. This Office hereby announces the list of public and private high schools who will participate the conduct of Prevalidation of Test Items of one of the Testing Program of the Bureau of Education Assessment (BEA) in this Division on November 12-16, 2018. This activity aims to establish the validity and reliability of various test items in the five (5) subject areas.
2. In line with this, public and private high schools are advised to prepare two adjacent classrooms to facilitate the conduct of the test.
3. One class is composed of forty (40) students.
4. Participants of this examination are Grade 7 and Grade 11.
5. Participants shall bring pencil during the test.
6. For November 13 to 15, there shall be one (1) class for G7 students and one class of G11 students. For November 12 and 16, there shall be two (2) testing sessions (AM and PM) in every sampled school.
