

CENTRALIZED TRAINING OF SELECTED CVIRAA ATHLETES BY THE WINNING COACHES FOR THE PALARONG PAMBANSA 2018

- To: Schools Division/City Superintendents
 All Others Concerned
- 1. In line with the preparation for the coming 2018 Palarong Pambansa which will be held on April 15-21, 2018 at Vigan City, Ilocos Sur, the conduct of centralized training and conditioning of CVIRAA delegation athletes qualified to participate the national competition, most especially for team events, shall be on March 19-28 and April 2-6, 2018 at the Cebu City Sports Complex hosted by the Cebu City LGU and DepEd Cebu City Schools Division. Home-based training had commenced right after the CVIRAA Meet 2018 and may continue to be conducted for individual sports events. This training will also continue for a week at Vigan City, Ilocos Sur upon the arrival of the delegation and before the actual competition of the Palarong Pambansa.
- 2. The training aims to: a) condition the coaches and athletes physically, mentally and emotionally; b) enhance the skills level of student athletes in their respective sports discipline; c) strengthen teamwork and camaraderie among members of the team; and d0 instill the values of sportsmanship while aiming to raise Team CVIRAA's performance in the 2018 Palarong Pambansa.
- 3. Facilitating winning Coaches shall coordinate with the different Division Sports Officers and vice versa for proper turnover and assurance of undertakings of their selected athletes in the team composition. The training shall be conducted at respective event venues which shall be coordinated by the facilitating Coaches with the Host Division Sports Officer, Mr. Francis Ramirez at mobile no. 0929-3489009. Division Sports Officer shall also inform Mr. Ramirez of the time of arrival and the number of athletes and coaches/chaperons coming from their respective divisions for their accommodation and meal preparation.
- 4. Travel, per diems and other incidental expenses incurred by the selected division coaches, asst. coaches, chaperons and athletes shall be charged to the respective division / school local / MOOE or any available funds subject to accounting and auditing rules and regulations while meals and accommodation shall be borne by Cebu City LGU and Cebu City Division, likewise with the host division of the home-based training venues to accommodate selected athlete coming from other divisions.
- 5. Facilitating Coaches are required to prepare the following documents for the training:
 - a) Training Program;
 - b) Record of attendance of athletes during lectures, drills and work-outs;
 - c) Narrative report of the training conducted; and
 - d) Other related observations and documents
- 6. Division Sports Officers are requested to supervise and monitor this training with their travel and other incidental expenses charged against division local / MODE funds subject to accounting and auditing rules and regulations.
- 7. Immediate dissemination of this Memorandum is desired.
