

Dear Dr. Bongalos,

Greetings of Peace!

The Philippine Statistics Authority (PSA) pursuant to Act 3753 or otherwise known as the Law on Registry of Civil Status, carries out, enforces and administers civil registration functions in the Philippines. Part of such function includes the release of civil registry documents to the public. In relation to this, it is noted that one of the requirements of the Department of Education are copies of the Certificates of Live Birth (COLB) of students enrolled in public schools. With many schools requiring the COLB of its students during enrollment, the PSA – Negros Oriental is currently experiencing large influx of clients at its Civil Registration System (CRS) Serbilis Outlet. As such, this office would like to be in close coordination with the Department of Education (DepEd) – Division of Negros Oriental in order to help regulate the number of clients coming in.

One of the initial actions we could suggest is for the DepEd of Negros Oriental to allow students to have 1-2 weeks lead time in complying with the COLB requirement, especially during enrollment. In addition, the DepEd could also have different schedules for each school for the submission of the said requirement. This would help minimize the volume of people going to the Serbilis Outlet at one time. Similarly, as the same is required from athletes for the yearly "Palarong Pambansa," the DepEd could also encourage schools to slowly identify participating athletes so they could start complying with the requirement as early as possible.

Along with these, the Batch Request System (BREQS) could be introduced to the students or parents. This is a scheme where PSA authorizes a partner (also known as BREQS User) to receive requests for PSA-issued copies and certifications of civil registry documents from the public and issue the documents to its clientele. With this, the public can avail of many of the services offered in the Serbilis Outlet through the authorized agent.

For your reference, we are providing below the list of our BREQS partners and the schedule of their transactions with PSA.

With that, we would also like to request the DepEd of Negros Oriental to allow schools to accept National Statistics Office (NSO) copies of civil registry documents of its students instead of strictly requiring them to submit PSA copies. The basis of which is the permanency of the records of a person in the civil registry documents since entries in the documents could only be changed or corrected through petitions under related republic acts or through a court order.

With the foregoing, we wish to ask for your support in this endeavor. If it merits your approval, we would also like to request for the dissemination of these suggestions to the public schools under the authority of your office. If deemed necessary, our office is more than willing to have a meeting or dialogue with you at your most convenient time to answer queries and clarifications.
