 - b. There will be no disruption of classes as stipulated in DepEd Order No. 9, s. 2005 entitled "Instituting Measures to increase Engaged Time-on-Task and in accordance with DepEd Order No. 39, s. 2009 entitled "Strict Adherence to DepEd Order No. 28, s. 2001 (Prohibiting the Commercialization of the DECS Organization through Endorsements and Accreditation of Goods and Services)";
 - c. Participation is purely voluntary and there shall be no collection of fees.
- The PSDS/School Principal has the blanket authority to stop the activity when violation is noticed.
- 4. Immediate dissemination of this memorandum is directed.
