 4. Wide dissemination of this Memorandum is desired.

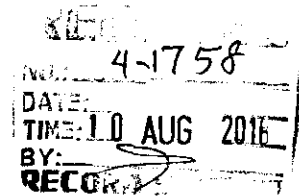
