### General Guidelines for the Conduct of the Division Kinder Day 2018

- 1. Each district shall conduct their own competition to select the best contestants in all categories.
- 2. Learner's contest categories are open to both public and private schools.
- 3. Participants to this competition are currently enrolled Kindergarten pupils aged 5 years old on or before August 31, 2018. A contestant is allowed to participate in one category only.
- 4. A contestant is allowed to participate in only one category.
- 5. BEST TEACHER DEMONSTRATOR and BEST IMPLEMENTING SCHOOL in KINDERGARTEN CURRICULUM is open only for PUBLIC teachers and schools.
- 6. Only Congressional District 1<sup>st</sup> place winners per category are qualified to join the contest in the Division Level. In case the 1<sup>st</sup> place winner is not available, the 2<sup>nd</sup> placer may represent the division.
- 7. Coaches are not allowed to stay in front of the stage/venue during the performance of their contestants. STRICTLY NO COACHING SHALL BE OBSERVED WHILE THE CONTEST/PRESENTATION IS GOING ON.
- 8. Coach in each category is required to submit a xerox copy of contestant's birth certificate and certification from the principal that the child is currently enrolled in the school and parents permit on the day of the contest.
- 9. The number of contestants in the registration form shall be his/her official number during the contest.
- 10. The coaches are reminded to secure duly signed permits from parents regarding their children's participation to the said contest.
- 11. Mechanics in the conduct of the contest per category is to be followed strictly. The judges will agree on the deductions to be given for every violation on the mechanics of the contest.

  Winners per category will be identified per criteria by the Board of Judges.
- 12. All winners will receive medals- 1st gold, 2nd silver, 3rd bronze.
- 13. The panel of Judges shall be composed of a Chairman and 2 members. The decision of the board of judges is final and irrevocable.
- 14. List of Congressional Level Winners and their coaches in the different categories shall be submitted to the Division Office 5 days before the date of Division Kinder Day in hard copy signed by the Chairperson of the respective venue.

#### **CRITERIA FOR DIVISION KINDER DAY CELEBRATION 2018**

### **MATHINIK**

### A. (Tangram Puzzles)

- 1. Contestant will be provided with 7 geometric pieces.
- 2. Each will be tasked to arrange the tangrams based on the given figure.
- 3. There are 5 rounds to complete the activity.
- 4. Contestant will be ranked according to the time they finished the task.
- 5. The contestant who will get the lowest to composite rank will be declared as winner.

### B. (Arithmetic Wiz)

- 1. It shall be composed of one (1) contestant and a coach.
- 2. The questions for this competition will be formulated from window card. -Addition-Subtraction
- 3. 3. All participants will undergo the window card exam.
- 4. Each pupil will take the exam individually.
- 5. No coach, faculty staff or representative from any school other than the participants will be allowed to enter the examination room before the exam.
- 6. Any questions during the exam should be addressed to the proctors inside the room.
- 7. Calculators, cell phones or any gadgets will not be allowed inside the examination rooms.
- 8. Only answer sheets, pens and window cards provided are allowed to be used during the exam.
- 9. All contestants will be advised to take toilet breaks before the start of the exam. Once inside the room, pupils are not allowed to go out.
- 10. Emergency situations will be handled by the proctors.
- 11. Any form of cheating and intellectual dishonesty will result to the disqualification of the pupil.
- 12. The top five (5) pupils with the highest score and fastest time will win.
- 13. In case of a tie, the involved pupils will compete in a tie-breaker round to fill the remaining slots.

### PICTURE READING- (Mother Tongue)

- 1. The contestant will be given 5 minutes for acquaintance with the pictures.
- 2. The picture story shall be delivered within 3 minutes.
- 3. The winners will be chosen by the panel of judges based on the general criteria below.
- 4. CRITERIA FOR JUDGING:
- A. Interpretation

>Vocal Expression	- 15%
>Proper Phrasing	-15%
>Timing	-10%
>Pacing	-10%

B. Projection

>Voice Mechanics	-10%
>Level of Confidence	-10%

C. Reading Fluency

>Accuracy	-10%
>Automatically	-10%
>Prosody	-10%

#### **COLORING**

- 1. Each contestant will be given a copy of the pictures they will color using crayons.
- 2. Contestants will bring their own materials for the contest.
- 3. The winners will be chosen based on the following criteria:

### Criteria for BEST KINDERGARTEN TEACHER DEMONSTRATOR (Literacy)

- 1. Contestants for this contest are Kindergarten Teachers in the PUBLIC schools only.
- 2. The demonstration will start from Meeting Time 1 to Post Reading and should show how to end the class. Choose any lesson covering the 3<sup>rd</sup> Quarter in the KTG.
- 3. Demonstrator may use projector or technology.
- 4. BEST TEACHER DEMONSTRATOR and BEST IMPLEMENTING SCHOOL in KINDERGARTEN CURRICULUM is open only for PUBLIC teachers and schools.
- 5. Board of judges will use the rating guide with the Blocks of Time during the Demonstration .

### Criteria for BEST IMPLEMENTING SCHOOL in KINDERGARTEN CURRICULUM (Music Video)

#### Guidelines

- 1. Required time limit is 5-7 minutes. A deduction of 1 point per exceeding minute shall be made.
- 2. The content shall revolve around Kindergarten curriculum Program implementation, innovations and shall be relevant to the theme (OMNIBUS POLICY).
- 3. Must be original in content.
- 4. The entry must be submitted within the prescribed period.
- 5. Background music must be appropriate.
- 6. Be G-rated (pornographic, racist, illegal or otherwise inappropriate videos will be automatically disqualified from competition)
- 7. Video does not need to be professionally produced. In fact, it is discouraged. A more down-to-earth style video production is preferred. Can be produced by your computer, your webcam or other video tool necessary to get your message across.
- 8. THREE AWARDS (First -place, second Place, and Honorable mention) will be chosen.
- 9. All decisions of the judges are final.
- 10. All appropriate videos submitted will be showcase on during the first day of Kindergarten Day.
- 11. Entry video shall be submitted on the end of this month (October 31, 2018).
- 12. The winners will be chosen by the panel of judges based on the attached general criteria
