Enclosed to this are the invitation letter (Annex 1), contest guidelines (Annex 2) and contest pass (Annex 3).

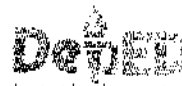
The delegations are expected to arrive on June 20, 2019 at 2:00 PM and to depart on June 22, 2019 at 12:00 noon.
