

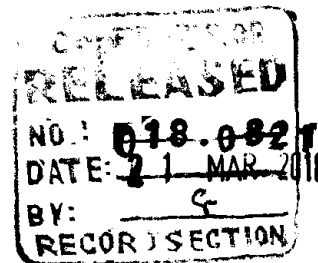



4. Emphasize good practices and points for improvement as seen in the partner agencies' perspective.


We hope that these initiatives would enable our respective agencies to create better partnerships, as well as a shared, supported and acknowledged contribution for the families whom we are serving.
