



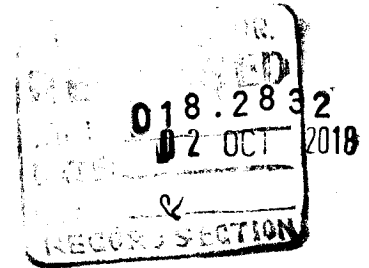

With the full implementation of the K to 12 Program and the rationalization plan in the Department of Education (DepEd), new policies and programs have been instituted and enhanced to further improve the delivery of basic education services.
