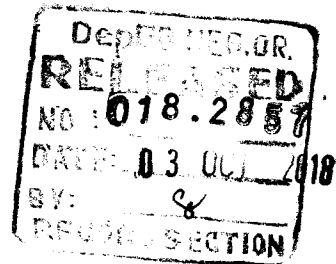

Dear **Dr. Bongalos**,

The Responsible Parenthood and Reproductive Health Act of 2012 (RPRH Law) is a landmark legislation aimed at protecting, promoting and fulfilling women's reproductive health and rights by accelerating the provision/delivery of and access to reproductive health care services and information. The Department of Health (DOH), as the lead agency in the implementation of the law, created National Implementation Team (NIT) to manage the execution of the law. To further strengthen institution of this coordination, the Regional Implementation Team (RIT) was created at the regional level.

As such, during the 2018 2nd RIT meeting, together with POPCOM, partners and stakeholders, it came to a consensus the necessity to organize and establish a Provincial Implementation Team (PIT) to facilitate and hasten mechanisms for the implementation of RPRH Law and fast track the reporting of the same as required by its IRR. In this regard, we would like to **invite a representative** from your agency that will become a member of the PIT to attend the **two (2) day 3rd Quarterly Meeting of Regional Implementation Team for RPRH Law cum Creation of PITs** for the provinces of Negros Oriental and Siquijor on **04 (starts at 1:00 p.m.) to 05 October 2018 (ends lunch time) in Dumaguete City, Negros Oriental** (specific venue to be announced through an advisory).
