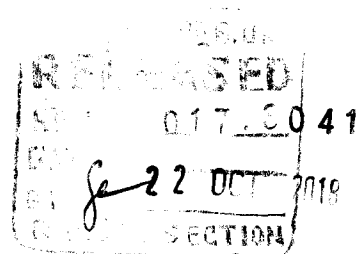

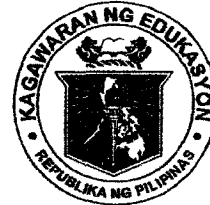

Recent developments in the City of Naga calls for our collective efforts as members of the Department of Education family as the city face the biggest challenge it has experienced, a landslide, claiming the lives of many Nagahanons.

It is very unfortunate that many of the victims are students and learners of the DepEd- City of Naga Division, including some of our teachers. Some of the retrieved bodies of our students were even pronounced dead and a teacher is still missing as of the moment. Many who were affected directly or indirectly are members of the DepEd Family- our family.

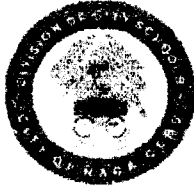
It is on this note, that I am respectfully requesting your kind support on our efforts to help bring back the lives of the victims to its normal condition. It may truly take a longer time for them to heal, but our concerted efforts would be of great help.

At present we are ardently needing the assistance of nurses and guidance counselors trained on conducting daily post- disaster psychological debriefing for adults and children (community folks and students) to help us in conducting the daily psychological/ stress/ trauma debriefing. We are requesting for at least twenty (20) personnel from each team/ division which will be allotted with two (2) days in conducting the activity. Inasmuch as the activity is a disaster response, it is further requested that each team shall also take care of their own provision for the 2- day activity. Response Team from each division are advised to report to the City of Naga Division Office on the scheduled date for final instructions.

Thank you very much in anticipation of your favorable action to this request.
