

1. The Department of Education Bureau of Learner Support Services (DepED-BLSS) through the School Sports Division (SSD) will conduct the 2018 National Accreditation Course for Officiating Officials scheduled from November 19 to 23, 2018 in Davao City. This course shall consist of theoretical lectures on rules of sports and practical application, paper and practical examinations and physical fitness tests.

SUBJECT : **2018 NATIONAL ACCREDITATION COURSE FOR OFFICIATING OFFICIALS**

DATE : **October 30, 2018**

1. The Department of Education (DepEd), through the Bureau of Learner Support Services-School Sports Division (BLSS-SSD), shall conduct the **2018 National Accreditation Course for Officiating Officials** scheduled from November 19 to 23, 2018 in Davao City.
2. The general objective of the National Accreditation is to accredit qualified school sports officiating officials to officiate in schools sports competitions such as the *Palarong Pambansa*. Specifically, the activity aims to:
 - a. update the officiating officials on the current trends, and rules and regulations in their respective sports disciplines; and
 - b. upgrade and improve their competencies in officiating and managing schools sports competitions.
3. The National Accreditation shall consist of theoretical lectures on rules of sports and practical application; paper and practical examinations; and physical fitness tests.
4. There shall be two (2) participants from each region per event except for Athletics with four (4) participants each, and one (1) participant each for Wrestling, Wushu, Dancesports, Pencak Silat, and Aerobic Gymnastics.
5. All participants shall be endorsed by the regional director and only those who were endorsed shall be strictly accommodated. However, in case of a replacement, the regional office shall issue a written communication authorizing the officiating official who will serve as a replacement for participant/s who will not be able to attend due to various compelling reasons.

6. Participants must meet the following requirements:
 - a. must be medically and physically fit, as evidenced by a **medical certificate issued by a government physician**. Pregnant women shall not be accommodated;
 - b. must not be more than 50 years old as of January 2018;
 - c. must possess knowledge and skills in their respective field of sports discipline;
 - d. must have officiated in the Division/Regional Meets for the past **three years, as certified by the Regional Sports Officer**; and
 - e. must bring their complete sports attire and personal sports equipment for practicum.

7. The regional office shall submit their respective list of participants on or before **November 9, 2018** to the Bureau of Learner Support Services-School Sports Division (BLSS-SSD) through email address: blss.ssd@deped.gov.ph or telefax number number (02) 632-0260.

8. Expenses relative to the conduct of the National Accreditation such as board and lodging, kits, honoraria for resource speakers and accreditors, travelling expenses of management staff, resource speakers and accreditors, rental of venues and transport vehicles, office and sports supplies and equipment, and other incidental expenses shall be charged to the 2018 Physical Fitness and Schools Sports Competitions including *Palarong Pambansa* Fund, subject to the usual accounting and auditing rules and regulations. Travelling expenses of participants, on the other hand, shall be charged to their respective local funds.
