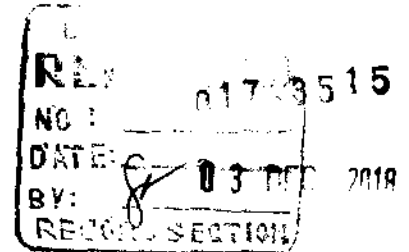

SEPTEMBER 26, 2018 RE 2018 REGIONAL FESTIVAL OF TALENTS (RFOT)**

TO: Schools Division/ City Superintendents

1.
