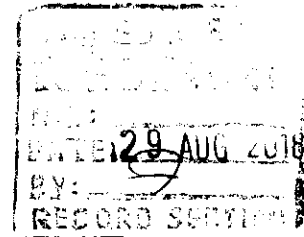

Attached herewith is the Authority to Travel from the office of the Municipal Mayor of Jimalalud.

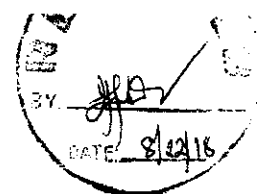
