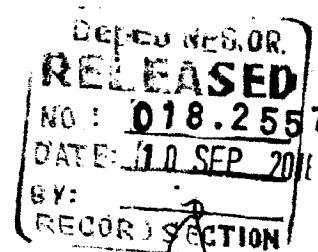

1. The Department of Education-National Employees' Union (DepEd-NEU) will conduct a series of **Clustered Assemblies on Responsible Public Sector Unionism** with the theme The Role of Management and DepEd-NEU in the Conduct of Responsible Public Sector Unionism on the following dates with respective venues:

2. The clustered assemblies aim to:

- a. strengthen harmonious Management-Union relationship,
- b. review some programs of the Management that directly or indirectly affect the rank-and-file employees,
- c. offer resolution to common issues/concerns about Management-Union relationship, and
- d. inform the rank-and-file employees on the various programs of the DepEd Management and DepEd-NEU.

3. The topics/issues to be discussed during the activity are the following:

- a. Status of the Rationalization Program after five years,
  - i. Rightsizing
  - ii. Possible reclassification/restructuring/addition of items/positions
- b. Responsible Public-Sector Unionism (RPSU) awareness,
  - i. Management Insights on Public Sector Unionism
  - ii. Partnership of Management and DepEd-NEU

- iii. Responsibilities and Accountabilities of Management and Union in relation to Public Sector Unionism (PSU)
- iv. Common Issues on Management-Union relationship, and
- v. Strategic Directions.

4. The participants in this activity are the DepEd-NEU Chapter executive officers in the central, regional, schools division, and school levels, who are all non-academic rank-and-file employees of the Department, including central, regional, schools division, and school administrative officers (AOs), human resource management officers (HRMOs)/personnel officers, planning officers, legal officers, attorneys, special investigation officers, information and communication technology personnel, medical officers, nurse, dental aids and officers, accountants, budget officers, supply officers, administrative assistants, utility employees and members of the DepEd-NEU National Board of Trustees and National Executive Committee, chairpersons and members of NEU steering committees.
