
REGIONAL MEMORANDUM

DCP Policy Review and Contextualization

TO : ALL SCHOOLS DIVISION SUPERINTENDENTS
ALL CONCERNED

1. The Information Technology Officers of the 19 Divisions and the Regional Office will be having a convergence to review and create/contextualize the issuances related to DCP into a DCP Handbook.
2. The contextualized DCP Handbook will provide the ITOs a common reference in the implementation of the computerization program and therefore will minimize if not eradicate issues, concerns and COA audit findings.
3. The convergence will be on February 7-9, 2018 at DepEd Regional Office VII, Sudlon, Lahug, Cebu City.
