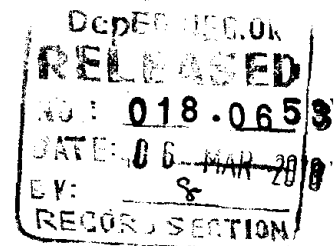

Travelling and other incidental expenses shall be charged against Division's MOOE Funds, while the expenses for meals, board and lodging shall be chargeable against Regional Funds.

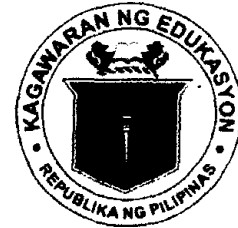
