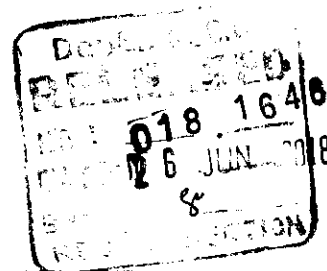

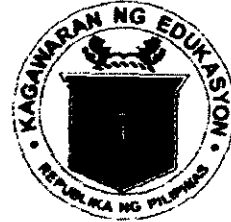

CRAFTING OF REGION VII TECHNICAL VOCATIONAL AND LIVELIHOOD (TVL) EDUCATION ROADMAP

To: **ALL SCHOOLS DIVISION SUPERINTENDENTS**
ALL OTHERS CONCERNED

1. In line with the effort of the DepEd Region VII to continuously improve the provision of access, relevant, liberating quality basic education, this office shall craft a **Technical Vocational and Livelihood (TVL) Education Roadmap**.

2. To ensure that the different provinces in the Region are properly represented and considered in prioritizing TVL programs, all Schools Divisions Offices of the four(4) provinces (Cebu, Bohol, Negros Oriental and Siquijor) are required to conduct a consolidation workshop to map out details of information that will be used in the TVL Roadmap.
