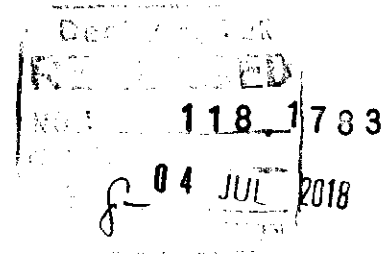

Dear **Mr. Patula**:

Greetings of Peace!

As stakeholders in the peace process of the government with the Rebolusyonyong Partido ng Manggagawa-Pilipinas/Revolutionary Proletariat Army/Alex Boncayao Brigade- Tabara-Paduan Group (RPM-P/RPA/ABB (TPG), OPAPP and PNP Peace Process and Development Center have scheduled a planning meeting with other offices which will be involved in the disposition of arms and forces under the Clarificatory Implementing Document to the 2000 GPH-RPM-P/RPA/ABB Peace Agreement.

The Planning Meeting is scheduled on **04-06 July 2018 (inclusive of travel time) at the Iloilo City Diamond Jubilee Hall, Iloilo City**, among OPAPP, PNP, and RPM-P/RPA/ABB (TPG) to operationalize the Implementation Plan on the Disposition of RPM-P/RPA/ABB (TPG) firearms, explosives and ammunitions, as crafted by the PNP RO VI FEADC, and approved by the Regional Director. The parties to this activity aim to tasking, timelines, and budgetary requirements for the firearms inventory/validation, as an initial process for DAF of the RPM-P/RPA/ABB in Western Visayas.

Expected participants for this activity are PNP units coming from the Provincial Police Offices of the four provinces, with the provincial directors, and representatives from operations, investigation, supply and accountability officers (SAO), Chief of Police from the seven (7) LGUs in Negros and Panay Islands, with the AFP Peace Process and Development Office.

The PNP, which is the lead organizer of this event, shall cover your travel expenses as well as hotel accommodation at the Highway 21 Hotel in Iloilo City for the duration of the activity.
