

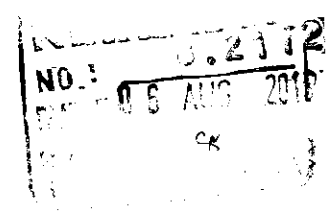

The Bureau of Learner Support Service (BLSS), through the School Sports Division (SSD), will conduct the **National Conference on Screening and Accreditation of Athletes and Coaches** from August 7 to 9, 2018 (exclusive of travel time) at the **Greenwood Apartments** in **Greenwood Village, Brgy.
