- 1. There will be a Three-Day Live -in Seminar Workshop on the Contextualization of Teaching Resource Materials in Multi-grade and Walkthrough of BOW on November 27-29, 2018, at Plaza Maria Luisa Suites Inn, Dumaguete City.
- 2. The training aims to:
  - a. To discuss the Multi-grade curriculum guides and its Budget of Work per Quarter:
  - b. To prepare and demonstrate lesson plans anchored from the K-12 curriculum; and

- 4. Registration will start at 7:00 A.M. on November 27, 2018 followed by an opening program at 8:00 A.M. Check in will be November 27, 2018 and check out is November 29,2018, after breakfast. First meal to be served will be breakfast of November 27,2018 and the last meal is afternoon snacks of November 29, 2018.
- 5. Expenses for board and lodging and training materials are chargeable against Multi-grade Funds. Transportation and other incidental expenses of trainers, and participants will be charged against School MOOE Funds. All expenses incurred relative to the training are subject to the usual accounting and auditing rules and regulations.
